By being part of this scheme, we have agreed to comply with the consumer code, giving our customers peace of mind when choosing us for their Solar PV systems.

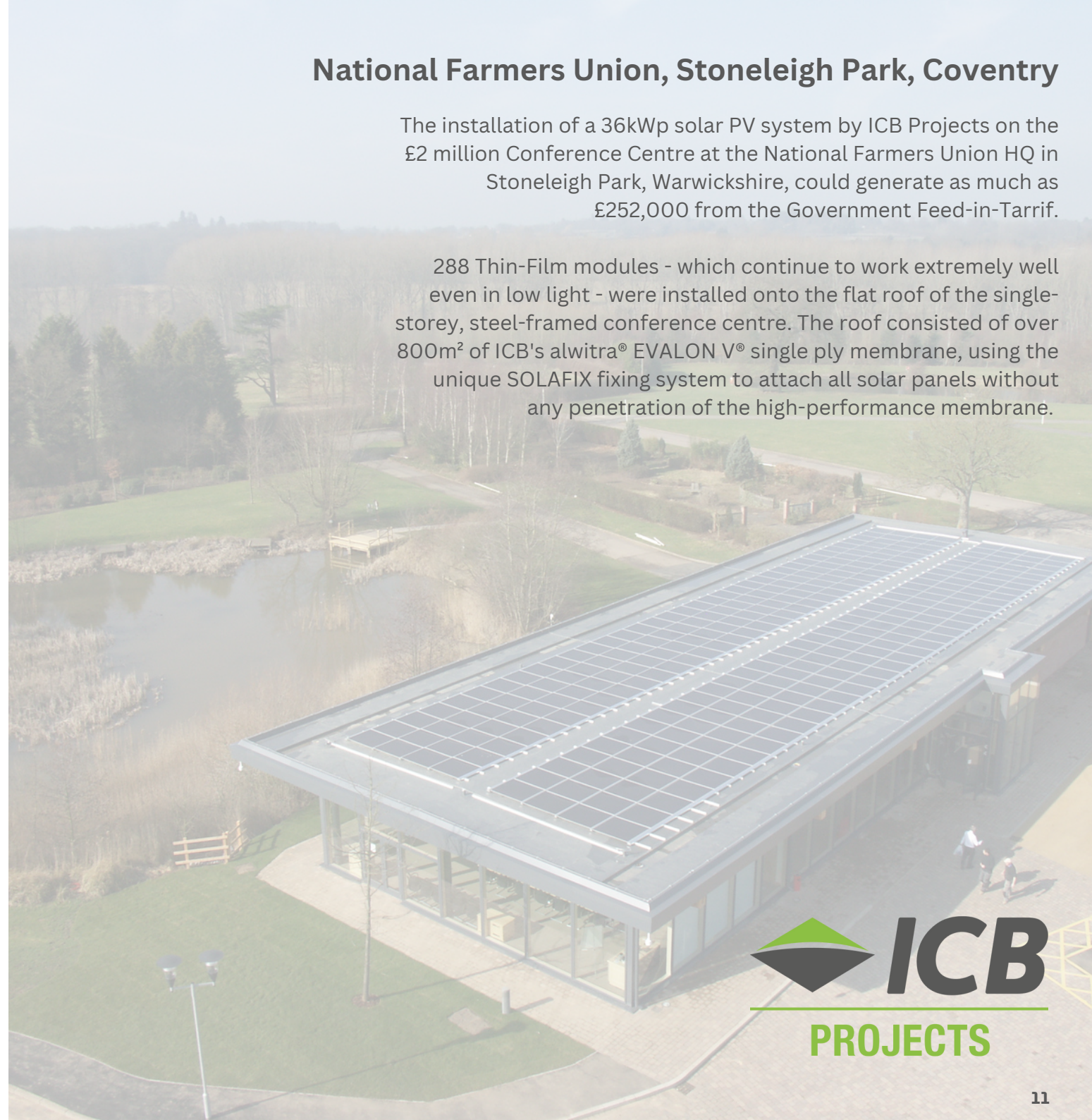

National Farmers Union, Stoneleigh Park, Coventry

The installation of a 36kWp solar PV system by ICB Projects on the £2 million Conference Centre at the National Farmers Union HQ in Stoneleigh Park, Warwickshire, could generate as much as £252,000 from the Government Feed-in-Tariff.

288 Thin-Film modules - which continue to work extremely well even in low light - were installed onto the flat roof of the single-storey, steel-framed conference centre. The roof consisted of over 800m² of ICB's alwitra® EVALON V® single ply membrane, using the unique SOLAFIX fixing system to attach all solar panels without any penetration of the high-performance membrane.
